MCL 710.23d states a temporary placement occurs when the adoptee is placed with the prospective adoptive parents, until parental rights are terminated. Once parental rights are terminated, the placement becomes a "formal placement".

The temporary placement documents shall be filed in the court in the county in which the child's parent or guardian or the prospective adoptive parent resides, or in which the child is found.

The following documents must be filed within 48 hours of the placement. Documents may be faxed to (313) 237-9307, Attention: Adoptions Coordinator.

- □ All Preplacement Assessments/Home Studies and any addendums. (Clearances must be updated within the past 12 months)
- □ Birth Verification from Hospital
- □ Database Main Form (Wayne County specific)
- □ Follow-up Report filed within 30 days, if the child was returned to the birth parent. If not, it is filed when the Petition for Direct Placement Adoption packet is filed. (If not received by the court within 45 days, the matter must be referred to the prosecutor.).
