## POST ADOPTION REQUESTS

#### **Certified Copy of the Order of Adoption**

If you are an adult adoptee, or the adoptive parents of an adoptee, you may request a certified copy of the Order of Adoption. Legal (court ordered) Guardians may also request a certified copy of the Order of Adoption.

#### **Passport**

The passport office may require a certified letter from the county in which an adoption took place when an adoptee or adoptive parent is attempting to obtain a passport, if there is a difference of more than six months between his or her date of birth and the date the birth certificate was registered with the state.

### Social Security and Secretary of State Assistance

The Social Security office of the Secretary of State office may require a certified letter from the county in which an adoption took place when an adoptee or adoptive parent is attempting to obtain a social security card or corrected piece of identification in the adopted name. This letter is to show both the adopted name, as well as the birth name. Please be aware that you must know the adoptee's birth name in order to make this request.

#### Friend of the Court Assistance

A biological parent may request a notice which can then be submitted to the Friend of the Court to prove that a biological child has been adopted. Also, a separate request/fee may be submitted to receive a copy of the order that terminated parental rights.

Please complete the attached request form and return it with the following documents to the address below:

- Copy of valid/current driver's license or other valid state picture identification
- Copy of the adoptee's birth certificate
- Copy of legal guardianship order, if applicable
- Fee \$10.00 Money Order made payable to the **Wayne County Clerk**. If more than one certified copy is being requested of the same document, each additional copy is \$1.00. If two separate documents are being requested, the fee for each certified document is \$10.00.
- Any other relevant documents/information

- 2) AN ORIGINAL BIRTH CERTIFICATE
- 3) A CONFIDENTIAL INTERMEDIARY TO ATTEMPT TO LOCATE A FORMER FAMILY MEMBER.
