RE: Judiciary Travel Rates Effective January 1, 2026

Please review the Judiciary's updated travel rates, effective January 1, 2026. You will note the standard mileage rate remains the same at \$0.470 per mile, which is based on the state's cost to operate a mid-sized vehicle. The premium mileage rate increased to \$0.725 per mile, which is the rate approved by the Internal Revenue Service. In addition, the select cities that were removed in October 2025 for Oregon and Puerto Rico have been readded to the select city list.
