 - ☐ b. The time periods during which the child(ren) lived at the addresses described in (a).
 - ☐ c. Whether Petitioner has participated in another child custody proceeding with the child(ren) giving the court, the case number, and the date of any custody determination.
 - ☐ d. Whether Petitioner knows of any proceeding that might affect this registration action (such as a custody enforcement action, a domestic violence action, termination of parental rights, or adoption), giving the court, the case number, and the nature of the proceeding.
 - ☐ e. The name and address of any person who is not a party to the registration proceeding who has physical custody of the child(ren) or claims rights to legal custody, physical custody, or parenting time with the child(ren).
