Condemnation Proceedings Docket Directive 1991-1: arising out of the western townships utilities authority for construction of sewage disposal system in the

Township of Canton Segment 1-C

As with other large volume condemnation proceedings, such as Cobo Hall and the Jefferson Avenue Expansion, I have agreed to conduct the show-cause proceedings for cases filed in conjunction with the above referenced sewage disposal system.

For your information, I have enclosed a list of the affected cases and the judges to whom they are assigned. The showcause hearings for these cases have been scheduled for Thursday, May 23. Please do not act in these cases prior to the conclusion of the show-cause proceedings since many of these cases are likely to be disposed of at that time or shortly thereafter.

As a final note, I anticipate the filing of another large block of condemnation actions related to the expansion of Metropolitan Airport in the near future. At this time, I am planning to handle the show-cause proceedings in these cases as well. I will keep you advised.
