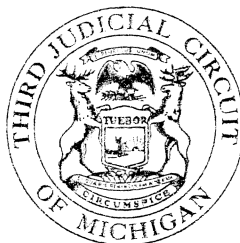

**SUBJECT: Reassignment of Dockets**

This Docket Directive is issued pursuant to MCR 8.110 and MCR 8.111(C) and is necessary to ensure the efficient transition of docket assignments.

**IT IS ORDERED THAT:**

**CIVIL DIVISION**

Effective January 2, 2003 the civil division docket (pending and post-judgment cases) of Judge Pamela R. Harwood is reassigned to Judge Michael F. Sapala.

**FAMILY DIVISION**

Effective January 2, 2003 the family division docket (pending and post-judgment cases) of Judge William Lucas will be randomly reassigned to family division dockets of Judges Michael Callahan, Amy Hathaway, Jeanne Stempien, and Carole Youngblood.

Effective January 2, 2003 the family division docket (pending and post-judgment cases) of Judge Sheila Gibson Manning will be randomly reassigned to family division dockets of Judges Michael Callahan, Amy Hathaway, Jeanne Stempien, and Carole Youngblood.

Effective January 2, 2003 selected pending DM, DO, DP, and DS cases will be reassigned to the family division dockets of Judges Michael Callahan, Amy Hathaway, Jeanne Stempien, Carole Youngblood, and Richard B. Halloran to equalize the pending caseload within the Family Division.

Effective January 2, 2003 the family division dockets of Judges Michael Callahan, Amy Hathaway, Jeanne Stempien, and Carole Youngblood will begin a full draw of domestic relation cases.

Effective January 6, 2003 post-judgment DM, DO, DP, DS cases initiated between 1994 and 2001 will be reassigned to the family division dockets of Judges Michael Callahan, Amy Hathaway, Jeanne Stempien, and Carole Youngblood to equalize the post-judgment caseload.

Effective January 2, 2003 Judge Chris Dingell is assigned to the family division juvenile section and will begin a full draw of child protective proceedings and delinquency cases.

Effective January 2, 2003 the criminal division docket of Judge Carole F. Youngblood is reassigned to Judge Susan Bieke Neilson.


Effective January 2, 2003 the criminal division pending docket of Judge Karen Fort Hood is reassigned to Chief Judge Timothy M. Kenny.

Effective January 2, 2003 the criminal division docket of Judge Michael F. Sapala is reassigned to Judge Thomas W. Brookover.


Effective January 2, 2003 the criminal division post judgment docket of Judge Karen Fort Hood is reassigned to Judge Harvey F. Tennen.
