

**SUBJECT: ASSIGNMENT OF JUVENILE CASES WITH INTENSIVE PROBATION UNIT (IPU)
ORDERS TO PRESIDING JUDGE SOLELY FOR ENTRY OF ORDER
TRANSFERRING PROBATION SERVICES TO WAYNE COUNTY FOR PROBATION
SUPERVISION**

IT IS ORDERED THAT:

1. This docket directive is issued in accordance with MCR 8.110(C)(3)(a) and (b).
2. Orders have been entered in multiple cases in the Juvenile Section of the Family Division that assign the juvenile respondents to probation under the Third Circuit Court Clinic for Child Study's Intensive Probation Unit (IPU). See attached list.
3. Upon agreement of the Third Circuit Court and Wayne County, the probation duties in these cases are being transferred from IPU to Wayne County for probation supervision.
4. For efficiency, the order transferring the cases from IPU to Wayne County for probation supervision will be signed by the Juvenile Section Presiding Judge, Hon. Edward J. Joseph. The cases shall remain on the docket of the previously assigned judge or judge team for all other purposes.

The Wayne County Clerk, the Third Circuit Court Case Processing Department, and the Third Circuit Court Information Technology Systems Bureau are directed to take the steps necessary to accomplish this Directive.
