
The Administrative Order rescinds and replaces Administrative Order 2018-01.

**IT IS ORDERED:**

**Pursuant to MCR 8.112(B), Local Court Rules, Administrative Orders, it is ordered that the following procedure for Judicial Assignments in the Third Judicial Circuit Court shall be effective immediately:**

- I. A judge may be assigned to another Division of the Wayne County Circuit Court when a vacancy occurs in that Division.
- II. The assignment to a vacancy in a Division shall be determined by the Chief Judge with consultation with Presiding Judges.
- III. Factors considered in determining the best interest of the Court in the assignment are:
  - a. status of the judge's docket and docket history;
  - b. impact upon the stability or status of current docket(s) should the judge(s) move into a different Division(s);
  - c. a docket that requires special or unique skills;
  - d. the judge's seniority and preference; and
  - e. the judge's demonstration of service by abiding by Court policies including the Court's attendance policy.
- IV. Pursuant to MCR 8.110(C)(3)(a)(b)(c) and (i), the Chief Judge retains the authority to reassign judges to divisions when necessary to properly dispose of the business of the court. Reassignments under this section may be made only to address the needs of dockets; improve the status of dockets; or when judges volunteer to exchange dockets.
